# FENCES

No fence or structure can obstruct the visibility of a driver backing out of drive or public way.

You cannot put up a fence or structure unless a permit is issued.

No hazard to the public can result from the construction of a fence or structure.

There is no height requirement, no restrictions for placement of property lines.

Swimming pools located within city limits must have at least a 4' secure fence around it.

Hedge fences can be no higher or wider than 6' along any street, alley, lane, avenue, or public ground.

## Housing Code

21

### § 152.048 FENCING OF SWIMMING POOLS.

All swimming pools within the city shall now be completely surrounded by a fence of not less than four feet in height entirely constructed upon the owner's property sufficient to restrain infants and toddlers from gaining access to the swimming pool.

This section shall not apply to a container which is designed or used for wading which will not permit the filling with water to a depth of 2-1/2 feet and which may be dismantled, stored, or moved to one place or another without the use of tools other than what is normally found in a household workshop. (Ord. 1988-27, passed 3-6-89) Penalty, see § 152.999

### § 152.048 FENCES.

No person, firm or corporation shall erect any structure or fence upon any premises so as to obstruct the visibility of the operator of any motor vehicle backing from any drive or public way.

No person, firm or corporation shall erect a fence or other structure limiting access to property unless a permit has been issued by the Safety and Service Director certifying that no hazard to public safety will result from such construction. There shall be no charge for such permit and denial of a permit shall be in writing setting forth specifically the hazard to public safety. The Director may establish rules for administration of this section and standards for automatic approval of applications for permits. (Ord. 1997-6, passed 4-7-97) Penalty, see § 152.999
