RATES AND CHARGES As of December 2014

§ 51.35 CHARGES FOR WATER TAPS.

- (A) All water customers shall pay a one-time access connection fee according to the size of service connection needed to the city water system, at the determination of the Safety and Service Director, as follows:
 - One-inch connection: \$2,500 plus the actual cost of the radio read meter, meter pit and \$30 inspection fee;
 - (2) Two-inch connection: \$3,200 plus the actual cost of the radio read meter, meter pit and \$30 inspection fee;
 - (3) Three-inch connection: \$4,500 plus the actual cost of the radio read meter, meter pit and \$30 inspection fee;
 - (4) Four-inch connection: \$9,000 plus the actual cost of the radio read meter, meter pit and \$30 inspection fee;
 - (5) Six-inch connection: \$15,000 plus the actual cost of the radio read meter, meter pit and \$30 inspection fee;
 - (6) Eight-inch connection or larger: \$30,000 plus the actual cost of the radio read meter, meter pit and \$30 inspection fee.

§ 50.28 RESIDENTIAL SEWER TAP FEES.

- (A)Residential sewer customers requesting a new connection to the city wastewater collection system shall, after approval of the connection, pay a fee for cost of sanitary sewer improvements based upon the size of the water connection to the same customer at the same location, as follows:
 - (1) One-inch diameter water tap customers shall pay a \$1,500 sewer tap, plus a \$30 inspection fee;
 - (2) Two-inch diameter water tap customers shall pay a \$2,000 sewer tap, plus a \$30 inspection fee.

§ 50.30 COMMERCIAL, INDUSTRICAL, MULTI-FAMILY TAP FEES.

- (A) Industrial, commercial, multi-family, or other similar structures, shall pay a charge according to the following schedule.
- (B) For any use not shown below, the number of use benefits shall be determined by the Safety and Service Director by the use of accepted engineering practice and on the basis of anticipated flow from the applicant when compared to a single-family residence where the flow of 400 gallons per day per residence will be considered as one use benefit.
