HILLSBORO CITY COUNCIL MEETING Hillsboro Municipal Court – 130 Homestead Drive

March 09, 2020

At 7:00 p.m., Council President Tom Eichinger called the Hillsboro City Council meeting to order. The following were present for the meeting: Clerk Kimberly Newman, Brianne Abbott; Safety and Service Director, Mayor Justin Harsha, Auditor Alex Butler, Public Works Superintendent Shawn Adkins and Chief of Police Eric Daniels.

ROLL CALL

Patty Day, Claudia Klein, Ann Morris, Mary Stanforth, and Adam Wilkin were present. Dane Allard and Brandon Leeth were excused.

Motion: Claudia Klein moved to excuse Adam Wilkin, seconded by Mary Stanforth. Vote all yeas. Mr. Leeth and Mr. Allard excused.

Mr. Eichinger led the Council in prayer and Mayor Justin Harsha led in the Pledge of Allegiance.

MINUTES

There were no corrections to the February 10, 2020 Regular Council minutes and were approved as submitted.

MONTHLY REPORTS

The February 2020 monthly reports were read by title only: Income Tax Bureau, Police Department, Public Utilities (includes Street Department, Water and Sewer Maintenance), Treasurer's (includes Expense and Revenue), Water Meter Department, Water Office (includes Water/Sewer Sales), Water Treatment, Wastewater Treatment, Code Enforcement and Auditor.

PUBLIC REQUESTS: Proclamation for 2020 Census Day April 1, 2020 was requested by and presented to Patty Day.

COMMUNICATIONS: Letter from Rebecca Gullette, subject- parking on Street at Deerbrook and Taylor Drive. Letter was given to Administration by Clerk of Council.

CITIZENS' COMMENTS: Jeretta Barr, Momma's Café 131 W. Main Street spoke to Council stating that due to the Parker Hotel demolition, there was a loss of income for 13 of Momma's café employees and as of today, 3-9-2020, the restaurant has been closed for 15 days. Ms. Barr inquired if the City could give a date when Momma's cafe could reopen. Mayor Harsha explained that David Osborne, the owner of 131 W. Main building had been notified on 3-6-2020 that his engineer could inspect the building on 3-7-2020. The Engineer did not come to inspect 131 W. Main Street on 3-7-2020. The remaining demolition debris will be cleared by 3-10-2020 at which time Mr. Osborne and his Engineer will be advised of the cleanup to do an inspection of the building. Once the City has a report from the Engineer of his inspection, the City will advise Ms. Barr when they can reopen.

Vote all yea.

Ordinance 2020-02 An Ordinance to amend portions of the Zoning Code and to amend the Zoning Map. Council President Tom Eichinger placed this in zoning and annexation committee, second reading on April 13, 2020

NEW BUSINESS: Ms. Patty Day was happy to report that after last months Council meeting and the discussion of the Homeless problem in the city, Ann Morris committee property maintenance & restoration and Claudia Klein committee-community enhancement will be joining Patty Day committee-zoning and annexation to jointly meet and create a committee name and discuss this issue. Council President Tom Eichinger would like a report in April on this new committee.
