#### CALL TO ORDER

Mayor Harsha called the meeting to order at 10:12 am.

### CORRESPONDENCE

Legal-from Clerk of Courts First State Bank vs. Robert L. Lowell, et al. Case No. 19CV0194 Email from Jared Jodrey – edited program guidelines during COVID 19 for RLF boards

**DISCUSSION** – The RLF reviewed all correspondence documents.

It was consensus of RLF to remove Lowell's landscape from loan list, as well as Classic and Warren Furniture recommended previous.

UNFINISHED BUSINESS Transferring Façade Improvement Program to CIC/HAEDC

**DISCUSSION** – Mayor Harsha and SSD Brianne Abbott advised the board that at his time, with the emergency funds of \$20,000.00 used from UDAG and the uncertainty of COVID19, the \$50,000.00 has not been transferred and will be revisited at a later, more secure time.

**NEW BUSINESS-** UDAG funds used for Parker Hotel Demolition-\$20,000.00 Mommas' West Main Café- loan relief request Update loan list for Auditor

**DISCUSSION** – Mayor Harsha explained to the RLF board that due to the emergency need of \$20,000.00 for securing the wall between Parker Hotel and Momma's café, the money was used for this purpose. This was not anticipated that the city would have to secure the wall, due to the demolition, Law Director Fred Beery advised Mayor and SSD that the UDAG funds could be used for this emergency need. The \$20,000.00 will be sought via reimbursement from the property owner, if this money is reimbursed, it will be placed back into UDAG funds. Momma's café requested relief from their RLF loan. Mayor Harsha told them to wait until RLF met on March 23, 2020. After the meeting the RLF would advise Momma's of board decision on relief. Momma's was shut done until the March 15,2020. On March 16, 2020 Momma's was allowed to reopen. Momma's did not reopen, then COVID 19 – Ohio Governor required Momma's to shut down the dining portion of the business, take out would have been allowable. Momma's café did not reopen for either purpose. Letter will be sent to Momma's- Jeretta and Bobbie Barr of board decision. See addendum #1.

MOTION: Mayor Justin Harsha moved, seconded by Steve Thompson to allow Momma's loan to be deferred until May of 2020, with no penalty of late fee. The loan will be reviewed for continued deferment at the May 2020 RLF meeting, with financial status given by owners by May 6, 2020. Vote all yeas.
