Hillsboro Finance Committee Meeting Dec. 19th @ 6:30 Hillsboro Municipal Conference Room

Meeting was called to order @ 6:30, all committee members were present, Ann Morris, Mary Stanforth and Justin Harsha.

Also in attendance. Kimberly Newman, Brianne Abbott, Kirby Ellison, Shawn Adkins, Dick Donley, Alex Butler and Patty Day.

Meeting was called to discuss the 2020 Budget.

Much more work has been done on the budget for 2020 and looks very good moving forward. There were many more cuts. Shawn had approximately 100k more cut from his budget. Gross – Feibel project was not able to be kept in the budget and many more line item cuts were made to bring up the carryover to \$156,451. Projected carryover for 2019 was \$210,000 but ended up being approx. \$805,000.

Built into the budget were funds for cruisers at the police department and three new hires to get to full staff. 3% pay increase across the board. Money for the possible demo of the Parker House Hotel. A new line item for community enhancement was made and funds also set aside for economic development. Computers for administration will be purchased as they are the oldest in the city. Inflow pumps at the sewage plant and a mixer for the water tower and many other necessities were budgeted for.

Dick reminded the committee to keep in mind bonding payment for the hotel project. This bonding hasn't been finalized at this point but needed to be taken into account for next year. With the carryover and the sale of property to PAS (59,000), the city should be covered moving forward.

Mary motioned to present the full budget for 2020 to full council. Ann seconded the motion. All were in favor.

Mary motioned to adjourn @ 7:20 and Ann Seconded the motion. Meeting was adjourned.
