DISCUSSION: Update: Avery Applegate met with Midway signs and presented a draft design to share with DRB members of step down and potential design for Marquee. Avery will continue contact and advised DRB that it may be necessary to go with a different company due to restructuring at Midway.

NEW BUSINESS:

• Steve Rivera Building Code Official, Lauren Walker Economic Development Assistant/Code Enforcement Officer

DISCUSSION: Steve Rivera introduced himself as building code official and gave his background, education and employment status with the city for the last two years. Mr. Rivera addressed concerns with DRB, Historic District, standards and enforcement of violations. Mr. Rivera recommended some changes to the DRB manual and a review of the purpose and enforcement of DRB. He also recommended having COA's Certificate of Appropriateness Applications be reviewed for approval after zoning and building department has reviewed for their purposes. This would eliminate confusion, conflicts, and unnecessary purchase of materials. Mr. Rivera gave several examples of conflicting issues in the Historic District that he has noticed and referenced for example to DRB. Adding, that the current Ordinance is missing the enforcement piece. Lauren Walker addressed DRB with recommendation of change of verbiage in the DRB manual, suggesting using words MUST, HAVE, rather than CONSIDER, MAY. Ms. Walker

stated the current words cause confusion and subjective review, and are not clarification words. She has reviewed other city DRB manuals and likes the verbiage used in them, as they clarify what is allowable and enforceable. Further discussions and actions are needed in the future.
