ROBIN MORRIS – OUTDOOR LIGHTING

DISCUSSION: Robin Morris discussed options of outdoor lighting in an alleyway. Lighting is currently strung across alleyway over city property. Morris was advised to submit a revised Certificate of Appropriateness to administration reflecting the changes to be compliant.

SSD ZONING OVERLAY DISTRICT RECOMMENDATION

DISCUSSION: Safety and Service Director Brianne Abbott advised planning commission of a proposed overlay district. Many questions were asked regarding the

overlay district. SSD Brianne Abbott preferred no action on such proposal at the October meeting and encouraged more discussion. Bill Sims noted allowing air BNB's may ruin neighborhoods. Sims also questioned if it would change property values. Chair Rob Holt added there would be no action immediately. Holt stated interest of reviewing Ohio Revised Code requirements for lodging to be sure it is reasonable and will benefit the entire community.
