Mr. McKenzie announced the Council committee meeting to discuss the zoning amendments on Thursday, March 22 at 7:00 p.m. Everyone was reminded about the Public Hearing for the Zoning Amendment on April 9, 2018 at 6:15 p.m.

Mr. McKenzie informed the Commission that Council passed legislation to approve an annual sidewalk program that is based on the size of the budget each year. The court case regarding the South High sidewalks was dismissed.

Mr. Eichinger said that the Planning Commission is recommending the adoption of the zoning amendment to full council. He said that when the Zoning Committee reviews the legislation he hopes they understand that the code will never be perfect, that it is a living document that should be changed as needed. It is not unusual for revisions to be required during the first year after the adoption of extensive code amendments. A mention of the Comprehensive Plan was made, stating it should be short in length but broad in scope. The zoning map will not change with the approval of the zoning code amendment.

Mr. Eichinger thanked everyone involved with the amendment of the zoning code. It required a lot of time and took approximately eighteen months to complete. Mayor Hastings said he considered the zoning code amendment to be one of the biggest accomplishments of his administration. Ms. Morris, Council member, said she felt Hillsboro had a great Planning Commission.
