December 15, 2022

At 7:00 p.m. Council President Tom Eichinger called the Hillsboro City Council meeting to order. The following were present for the meeting: Clerk Whitney Aliff, Mayor Justin Harsha, Public Works Superintendent Shawn Adkins, Auditor Patty Day, Chief of Police Eric Daniels and Law Director Randalyn Worley. Safety and Service Director Brianne Abbott was absent and excused.

MOTION: Mary Stanforth moved to excuse Brianne Abbott, seconded by Greg Maurer. Vote all yeas. Safety and Service Director Brianne Abbott excused.

ROLL CALL

Don Storer, Dan Baucher, Mary Stanforth, Adam Wilkin, Jason Brown and Greg Maurer were present.

Mr. Eichinger led the Council in prayer and Mayor Justin Harsha led Council in the Pledge of Allegiance.

MINUTES

There were no corrections to the November 17, 2022 regular council minutes. They were approved as submitted.

Electricity Aggregation Program

DISCUSSION: Council President Tom Eichinger shared previous Planning Commission member Charlie Guarino sent a letter with information on aggregation programs for the City of Hillsboro. A representative has contacted administration sharing benefits and cost comparisons. Mr. Eichinger placed the aggregation communication into the utilities committee, chaired by Greg Maurer. Clerk Whitney Aliff will provide the committee the supplied documents regarding aggregation for gas and electric.

COMMUNICATIONS FROM THE MAYOR (Justin Harsha, Mayor)

Mayor Harsha began by discussing the Local Board of Income Tax Review appointments. The board serves a two-year term and is made up of three individuals. One person is appointed by the mayor, with the other two being appointed by Council. Mayor Harsha recommended Tim O'Hara and Anne Griffith. Council was in favor of the recommendations. Mayor Harsha noted the community loss of two instrumental assets; Betty Bishop and Buck Wilkin. Harsha wishes to thank the family of the two individuals as they both served their community well.

MOTION: Adam Wilkin made a motion to appoint Tim O'Hara and Anne Griffith to the Local Board of Tax Review, seconded by Greg Maurer. Vote all yeas. Tim O'Hara and Anne Griffith appointed to the Local Board of Tax Review for a term of two years.

Mayor Justin Harsha reported for both himself and Safety Service Director Brianne Abbott. The Safety and Service Directors report included positive remarks from community partners in support of the West Main Street Greenspace, Amphitheatre and Rails to Trails program. When applying for technical assistance on the project, notification was received last minute that letters of support were necessary to the application. In less than 24 hours, our community partners provided us with 10 letters. Mayor Harsha read off snippets of the support letters.

DISCUSSION: Council President Tom Eichinger explained this would allow the creation of the committee for Imagine Hillsboro bi-annual review. Second reading January 12, 2023.

Resolution 22-45 A Resolution for the transfer of various funds for fiscal year 2023.

MOTION: Greg Maurer moved to approve and adopt Resolution 22-45, seconded by Mary Stanforth. Vote: Don Storer-yes, Greg Maurer-yes, Adam Wilkin-yes, Dan Baucher-yes, Jason Brown-yes, Mary Stanforth-yes. Resolution 22-45 approved and adopted.

DISCUSSION: Auditor Patty Day noted Resolution 22-45 allows the movement of money through 2023. Day added this is mostly for debt payments from the general fund. Councilmember Mary Stanforth questioned if the amounts remain the same. Day answered yes, if any amount changes it would require additional legislation.

DISCUSSION: Auditor Patty Day advised Ordinance 2022-31 is for the 2023 budget and was recommended by the finance committee.

DISUSSION: Auditor Patty Day explained Ordinance 2022-32 is an appropriation to payoff a bond.

Subject: Application of a DORA (Designated Outdoor Refreshment Area) for the city of Hillsboro.

Summary: The meeting of Street and Safety regarding a DORA district began on time.

As before the main portion of this discussion was about details. Details such as the boundaries, signage used for designation, hours of operation, public safety, and a plan for sanitation are, among other things, items that will have to be clarified and taken care of before this committee can recommend bringing the idea of a DORA district before full council for approval, though this committee agrees that this can be a positive for our city.

The State of Ohio requires a detailed application to be completed by the executive office of the city for approval before moving forward with any legislation regarding the creation of a DORA district within the city. The city must offer a public hearing before any legislation can be moved before full council.

It is the recommendation of The Street and Safety Committee that the city administration move forward with the application process to the State of Ohio.
