# CALL TO ORDER

At 5:42 p.m. Chair Bill Sims called the Hillsboro Planning Commission meeting to order immediately following the public hearing.

# ZONING MAP AMENDMENTS – JOINT WITH ZONING & ANNEXATION COMMITTEE

DISCUSSION: Planning Commission Chair Bill Sims discussed a document that was received requesting 1331 North High Street be rezoned from Residential A to Business C. Mr. Sims noted the location is in a commercial strip. The proposed use is for a financial institution. Planning Commission member Rob Holt added the property does abut with

residential single-family housing. Mr. Holt recommended the zoning be changed from Residential A to Business and Residential D. Member Amy Davis asked what limitations that would set on the property. Rob Holt shared Business and Residential D zoning will allow Business C uses plus multi-family housing. Representative for the zoning change Mark Wilson advised the intention with the property is banking. The current owner of the land has owned the land for 60+ years and is an abutting property owner in a residential home. Mr. Wilson advised the business would be normal banking hours. Chair Bill Sims noted the property is roughly 6+/- acres and asked for potential use of the land. Mr. Wilson estimated roughly three acres would be utilized for a financial institution. MOTION: Bill Sims moved to recommend to council to rezone 1331 North High Street from Residential A to Business and Residential D, seconded by Amy Davis. Vote: Justin Harsha-yes, Rob Holt-yes, Paul Worley-yes, Amy Davis-yes, Bill Sims-yes. Recommendation will be provided to council and clerk Whitney Aliff will send letters to property owners and schedule the public hearing. Legislation will be requested to submit for council approval.

# COMMERCIAL SITE PLAN – TERRACE AVENUE

DISCUSSION: Planning Commission Chair Bill Sims reviewed the submitted site plan for Terrace Avenue, 10 proposed 2-bedroom cottages, Mr. Sims asked if utilities were available. Public Works Superintendent Shawn Adkins advised water is tapped off at Springlake Avenue and sewer is to the north of the properties. Applicant Randy Plickerd provided an updated layout to planning commission members as some information has changed from the original plan. Mr. Plickerd indicated interest in purchasing vacant lots from abutting property owners. Discussion was had on the possibility to request an alley vacation if a private drive is being put in. Planning Commission member Rob Holt noted the lots are currently zoned Business and Residential D, which prohibits single family dwellings. Randy Plickerd added the plan is to build the "pocket park" and sell the homes to individuals. A HOA would govern the land per Mr. Plickerd. Parking regulations were discussed. The current zoning code requires two parking stalls for each single-family home. The proposed layout showed 9 homes and a community room. Discussion was had on requesting a zoning change and a P.U.D. overlay. Members of planning commission have sympathy for the applicant as housing is needed. Planning Commission chair Bill Sims instructed the clerk to add "Rezone Terrace Avenue" to the July planning commission agenda.

MOTION: Bill Sims moved to disapprove commercial site plan for Terrace Avenue, seconded by Rob Holt. Vote: Bill Sims-yes, Amy Davis-yes, Paul Worley-yes, Rob Holt-yes, Justin Harsha-yes. Commercial Site Plan for Terrace Avenue disapproved.
