ORDINANCE NO. 2023-33

**AN ORDINANCE TO AUTHORIZE THE DISPOSITION OF UNNEEDED MUNICIPAL
PERSONAL PROPERTY PURSUANT TO OHIO REVISED CODE SECTION 721.15**

WHEREAS, pursuant to Ohio Revised Code Section 721.15, personal property not needed for municipal purposes, the estimated value of which is more than one thousand dollars (\$1,000.00), shall be sold only when authorized by an ordinance of the legislative authority of the municipal corporation and approved by the board, officer, or director having supervision or management of that property; and

WHEREAS, at the request of the Public Works Superintendent, the City of Hillsboro owns an item of personal property, more particularly a 1992 F-700 Dump Truck, 47,365 Miles, Serial #1FDXF70J2NVA10064, not needed for municipal purposes, and the estimated value thereof being in excess of one thousand dollars (\$1,000.00); and

WHEREAS, the Public Works Superintendent, shall make a written contract with the highest and best bidder after advertisement for not less than two nor more than four consecutive weeks in a newspaper of general circulation within the City of Hillsboro or as provided in section 7.16 of the Revised Code.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF HILLSBORO, STATE OF OHIO, WITH A MAJORITY OF ALL COUNCIL MEMBERS CONCURRING THAT:

SECTION 1: That the City of Hillsboro shall dispose of the following personal property items owned by the City of Hillsboro, not needed for municipal purposes, and the estimated value of which is more than one thousand dollars:


1992 F-700 Dump Truck, 47,365 Miles, Serial #1FDXF70J2NVA10064

SECTION 2: The disposition of the personal property set forth is authorized pursuant to Ohio Revised Code Section 721.15, and the Public Works Superintendent shall make a written contract with the highest and best bidder after advertisement for not less than two nor more than four consecutive weeks in a newspaper of general circulation within the City of Hillsboro or as provided in section 7.16 of the Revised Code.


SECTION 3: That it is found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal actions were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

SECTION 4: This Ordinance shall take effect and be in full force at the earliest period allowed by law.
