A RESOLUTION AUTHORIZING THE SAFETY AND SERVICE DIRECTOR TO PURCHASE A PLAYGROUND THROUGH THE STATE OF OHIO COOPERATIVE PURCHASING PROGRAM AND DECLARING AN EMERGENCY

WHEREAS, the City of Hillsboro desires to install a playground at Railroad Street Park; and

WHEREAS, the City of Hillsboro participates in the State of Ohio Cooperative Purchasing Program, and a playground is immediately available for the city to purchase. (See Exhibit A).

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF HILLSBORO, STATE OF OHIO, WITH 2/3 OF ALL COUNCIL MEMBERS CONCURRING THAT:

SECTION 1: That the Safety and Service Director is hereby authorized to purchase a playground through the State of Ohio Cooperative Purchasing Program.

SECTION 2: That it is found and determined that all formal actions of this Council concerning and relating to the passage of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal actions were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

SECTION 3: This Resolution is declared to be an emergency measure, and Council has dispensed of three necessary readings and is essential to the immediate preservation of the public health, safety, and welfare of the residents of the City of Hillsboro, Ohio to immediately allow construction to begin and shall become effective at the earliest date allowed by law.
