September 12, 2024

At 7:00 p.m. Council President Tom Eichinger called the Hillsboro City Council meeting to order. The following were present for the meeting: Mayor Justin Harsha, Safety and Service Director Brianne Abbott, Public Works Superintendent Shawn Adkins, Auditor Dawson Barreras, Law Director Randalyn Worley, Clerk Whitney Aliff and Pro Tem Clerk Lauren Walker.

Mr. Eichinger led the Council in prayer and Mayor Justin Harsha led Council in the Pledge of Allegiance.

MINUTES

COMMUNICATION FROM THE MAYOR (Justin Harsha)

Mayor Harsha introduced two people to council. Hannah Koogler was an intern for the city and prepared a presentation for council. Hannah Koogler addressed council and explained in detail various tasks during her time with the city. Tasks including; helping with parks and recreation, organizing records closet, basic government standards, organizing letters, organized papers for city events, attended a council meeting, attended and understood roles of city council and elected officials, put together bags for senior week, learned about senior scholarship and senior week, handed out trees at the elementary school with the mayor and learned it is hard work for the city but thankful for the opportunity. Mayor Harsha thanked Hannah Koogler. Mayor Harsha introduced Parks

and Recreation Director Caleb Gregory to report on happenings of the parks this year and what's to come. Caleb Gregory gave a quick update on his first year at Shaffer Park. Caleb Gregory first thanked everyone who was involved in making this year such a success. The parks crew, ground crew 3 high school boys, 4 interns at the concession stand, local businesses, organizations, coaches, umpires, parents, and of course the kids. Caleb Gregory stated they ran a full 10 weeks of games with only a half-day rainout, which is pretty remarkable. We were able to generate \$32,000 in revenue through player registration, sponsorships, donations, and our concession stand. All of the funds will go right back into Shaffer Park. We hosted 43 teams this year at Shaffer Park, and we're excited to continue growing that number each year as the word spreads and our community expands. Our goal is to provide even more opportunities for players, families, and spectators to enjoy everything the park has to offer. The first big project we are investing in is new fencing for all several fields. We've already started making small improvements, and we're excited about what's to come. In other updates, Caleb Gregory shared that the pickleball courts have been a huge success. Caleb stated if you've been by in the morning or evenings, you'll know they're always packed and parking lot full. We're excited to announce our first major pickleball tournament, the Bell City Open, which will take place on September 21st-22nd. For anyone interested in joining, contact the Hillsboro Ohio Pickleball Association. The restrooms are also being improved and should be ready soon. Caleb Gregory then went into detail about the upcoming construction of the Ninja Course at Railroad Street Park. The parking lot may be coned off on certain days, please be patient. Caleb Gregory gave a brief update of Harmony Lake / Liberty Park explaining the new playground, archery range, landscaping, and upcoming events. Caleb Gregory gave a special thanks to Good News Gathering and Hillsboro Sophomore class for landscaping and trash pick-up. Caleb stated he is looking at a couple events like a training and safety session, nature trail-walk, and even a flag football tournament for adults. Caleb Gregory thanked council for their time and support and that he looks forward to continued improvements across our parks.

REPORT OF THE SAFETY&SERVICE DIRECTOR/HILLSBORO PLANNING COMMISSION

Brianne Abbott shared, "As you may know, the City issued a Phase II Water Emergency on September 10, 2024. According to records, this was the 11th driest August on record in 130 years and much of Hillsboro is currently at a D3 extreme drought level on the US drought monitor. Highland County was declared a primary natural disaster area due to drought, according to the United States Department of Agriculture Farm Service Agency. City officials have been monitoring the drought and our water levels over the last several weeks. Our reservoirs are much lower than we've seen. Maybe you've caught a glimpse of the reservoir visible from US 62 South, or maybe you've just noticed the dying lawns and lack of precipitation lately. All of these and more brought us to the conclusion that water conservation is a necessity at this point in the drought. We most definitely want to get ahead of extreme disaster and conserve now to help extend our water supply. At this point in time, the city has about 80 days of water supply left. If and when we hit the 30-day mark of supply, the City will then issue a level 3 emergency, which will have more strict guidelines for conservation. Currently, at a level 2 emergency, the following are prohibited as outlined in Ordinance 51.064: watering lawns, flowers, trees, shrubs, or gardens; washing parking lots, driveways, or sidewalks; cleaning of motor vehicles except in a high-pressure pay care wash facility; filling

swimming pools or fountains; or any other non-essential use. We appreciate your cooperation while we continue to conserve water in a time of extreme drought." Brianne Abbott asked council if there were any questions regarding the water emergency. No comments or questions. Brianne Abbott made a request for an executive session per ORC 121.22 (G)(4) Preparing for, conducting or reviewing the negotiations or bargaining sessions with public employees concerning their compensation or other terms or conditions of their employment. Moved by Mr. Wilkin to enter executive session, seconded by Ms. Stanforth. Mr. Bacher-yes, Mr. Brown-yes, Ms. Sanborn-yes, Ms. Stanforth-yes. Mr. Storer-yes, Mr. Wilkin-yes

Executive session was entered at 7:14pm. 7:25pm, Council President announced council was back into regular session.
