UNFINISHED BUSINESS

• VETO of ORDINANCE 2025-20

Reason(s) for Veto: Objections;

- Council Member Kathryn Hapner participated in a vote on Ordinance 2025-20, which
 pertains to the salary of the Code Enforcement Officer. At the time of the vote, Council
 Member Hapner had an unresolved, open code enforcement violation against her property
 which is a direct conflict of interest.
- 2. At the time of the vote on Ordinance 2025-20, Auditor Barreras was actively awaiting a

written legal opinion, as recommended by the State Auditor's consultant, regarding specific aspects of the ordinance. This legal opinion had not yet been received at the time the ordinance was brought to a vote. Proceeding with a vote while a legal determination was still pending undermines due process and the integrity of legislative procedure. Specifically, the section of the ordinance related to the legal opinion in question should

have been tabled until the opinion was formally obtained and reviewed. Moving forward with a vote under these conditions was premature and potentially in violation of recommended oversight and best practices for municipal governance.

3. Upon review of the official record, the recommendation for modification referenced in support of Ordinance 2025-20 did not explicitly identify or refer to a specific title or position. The absence of such specificity raises concerns about the appropriateness and applicability of the recommendation to the salary adjustment in question. Without clear reference to the Code Enforcement Officer or any defined role, it is procedurally unsound to use this recommendation as justification for the legislative action taken. Legislative decisions, particularly those involving budgetary or personnel matters, must be supported by clearly documented and directly applicable recommendations or findings. In this case, the vague nature of the referenced recommendation fails to meet that standard.
