-Site Plan Review- Valvoline LLC- 1225 N. High St., Hillsboro

DISCUSSION- Mike Mihalik & Robin Peck spoke on behalf of the Valvoline & what the project entails. Rob Holt confirmed easement is in process & that was verified by Mike Mihalik. Rob Holt asked how many employees for parking purposes. Mr. Mihalik stated that there will be 5 employees & there are 9 parking spots & it is a drive thru facility. Bill Sims asked if there is a concrete drainage tank & Mr. Mihalik explained how the fluid is removed from the building & how the water/oil separator works. Signage was also discussed, that will come in later permits.

Rob Holt asked about a turn lane & Brianne Abbott stated there is an intersection project on Fenner that will be sufficient for that. Mrs. Abbott has concerns of the 73-driveway cut & not being 500' from Fenner. Shawn Adkins also stated he had concerns, but 73 should be right turn only in & out of 73. Mrs. Abbott asks to please put condition for right turn only in/out to 73.
