CITY OF HILLSBORO, OHIO ORDINANCE NO. 2025-22

AN ORDINANCE MAKING SUPPLEMENTAL APPROPRIATIONS FOR THE CITY OF HILLSBORO, HIGHLAND COUNTY, OHIO

WHEREAS, pursuant to Ohio Revised Code §5705.40, any appropriation ordinance or measure may be amended or supplemented, provided that such amendment or supplement shall comply with all provisions of law governing the taxing authority in making an original appropriation and that no appropriation for any purpose shall be reduced below an amount sufficient to cover all unliquidated and outstanding contracts or obligations certified from or against the appropriation; and

WHEREAS, Council previously passed Ordinance 2024-62 to make appropriations for current expenses and other expenditures of the City during the fiscal year ending December 31, 2025; and

WHEREAS, Council may decide to appropriate additional funds in order to spend OWDA funds and other funds for the Roberts Lane Roadway invoice, and that supplemental appropriations be made to appropriate funds not heretofore appropriated.

NOW THEREFORE BE IT ORDAINED, by the Council of the City of Hillsboro, Highland County, Ohio, a majority or more of all members thereof concurring as follows:

SECTION 1. That there is hereby appropriated, funds previously unappropriated as follows:
