#### **UNFINISHED BUSINESS**

Law firm and give more information at March meeting. Mayor Hastings revisited the possibility of spending \$300.00 a month on a bookkeeper/ accounting firm to handle the loans, delinquency and compliance, reiterating that the RLF is not a collection agency. Amy Hamilton discussed that financials should be collected quarterly and annually. A better relationship with the applicants should be in the RLF interest. Suggestions that Chris Lewis may be of help in this matter of finding an outfit to accommodate the financial portion of RLF and the loan delinquency issues. RLF Committee will contact Mr. Chris Lewis. New Applications were updated to be more thorough and concise to avoid further delinquent loans.

# **NEW BUSINESS**

- Mel McKenzie had contact with the Realtor for the March 29 or April 1, 2019 closing of the BP property. Greg VanZant has approved the purchasing agreement, surveys are filed for the property. Bart Guiterrez owns the Swonger property and he is on board with CIC closing on Lykins BP, then closing with him (Mr. Guiterrez) on the BP property with the parking lot being the down payment for the BP. Parcels must always be as one so the encroachment is not an issue in the future. Mr. Guiterrez is proactive is getting tenants in the BP location, possibly a BBQ restaurant.
- Mayor Drew Hastings has talked to Lisa Parsley, owner of Shabby Moose, about some of his properties, Mr. Hastings wanted to be on the record for transparency purposes, that his properties have been considered. Ms. Parsley would like to move the Shabby Moose location, as she needs more space and wants an uptown location. Ms. Parsley has not made a decision on a location change at this time.
