AN ORDINANCE TO ASSESS THE COST OF LEGAL FEES TO REVOLVING LOAN FUND TRANSACTIONS IN BREACH OR DEFAULT

Be it ORDAINED by the Council of the City of Hillsboro, State of Ohio, that

SECTION ONE: In any case wherein the Revolving Loan Fund Committee must bring collection or other enforcement action necessitated by the breach, violation or default of a loan recipient, the legal fees incurred by the City or the Revolving Loan Fund Committee in consulting counsel, litigating the matter in court or negotiating, including alternative dispute resolution, shall be assessed to the loan recipient or the loan recipient's successor in interest.
