**The following submittals are required for review of the sign application:**

---

- Completion of the application.
  - Drawings to an appropriate scale showing:
  - The design and layout of the proposed sign, including the total area of the sign, and the size, height, character, materials and colors of letters, lines, and symbols.
  - If more than sign or sign face is proposed, separate information of each sign or sign face shall be provided.
  - A site plan showing the exact location of the sign(s) in relation to all buildings, right of way and property lines.
  - The method of illumination, if applicable.
  - Details and specifications of construction, erections and attachment of signs showing compliance with Article 600 of the National Electrical Code (NFPA 70), Section 3107 of the Ohio Building Code (OBC) and/or Chapter 153 of the City of Hillsboro Codified Ordinance.
  - Any other information required to complete the review.

**Sign Permit Fees:**

---

\*\*\*Signs that are under 12 sq. ft. that are not electrified will not go to the Building Department and do not require inspections.

Fascia, Marquee, Projecting, Pylon, Pylon Advertisement, Monument Sign, Face Change, or Yard Arm Sign \$100

Awnings without advertisement \$50

Awnings with advertisement \$100

Payment not due until approved.

\*\*\* Signs that are over 12 sq. ft. and/or are electrified will go to the Building Department and require inspections. Fees will be calculated by Building Inspector and could be more than what is stated below.

Signs less than 30 sq ft - \$125.00

Signs over 30 sq ft - \$250.00

Awnings may require inspection

Plan Review Fees: \$100.00 plus actual costs

3% OBBS surcharge applies to total permit fee less plan review charges.
